**Auditions will be held on the 7th of May and the 14th of May 2017, from 1 to 5 pm
at 2 Shaftsbury Rd (behind Lyonpark), West Ryde NSW 2114**

The Grand Final:

- The top 3 performances in each category from the audition sessions will be chosen to perform in the grand final of the **SAFAL FEST** talent hunt

**The grand final will be held on the 21st of May, from 3 to 5 pm
at Macquarie University, North Ryde 2109**

Eligibility:

All performances must feature at least one member of South Asian descent
OR

The Performance must have a South Asian theme

- Performers must be aged 15 or over
- Group dances can have up to 6 members
- Performances must have a maximum duration of 5 minutes

Terms and Conditions:

- All performers under the age of 18 must have the consent of their parent or guardian (Proof of ID is required)
- All performers must have a valid Australian visa or be a resident of Australia
- Audio tracks must be provided either on a USB or CD (We will not accept tracks played on a mobile phone or from YouTube)
- The producers of each item must have obtained the rights to use any media which they plan to use as part of their performance
SAFAL FEST is exempted from all liabilities arising from media usage rights, with regards to this performance
- Dance performances will be judged on dress, music, poise, grace, steps
- The decisions of the judges are final
- The SAFAL Committee reserves the right to publish photos and video recordings of the performers, for the sole purpose of promoting both this and future events.
- Performers must report to their allocated area 20 minutes before their designated performance time
- The SAFAL Committee reserves the right to refuse participation to performers who do not report on time
- The show line up will be formulated by the SAFAL Committee, and will not make any changes to the line up unless there are compelling circumstances
